If a landlord sends a tenant a 5 day notice for not paying rent, the tenant can stop the eviction by paying all of the rent due. If the tenant can pay only part of the.

If your landlord is trying to evict you for owing rent, you can stop the eviction by paying what you owe. You can do this at any time in the process before the Sheriff. You cannot permanently stop an eviction, even when you are experiencing financial hardship. Understanding the process and how to negotiate.

If you have a lease and you receive a notice to quit for non-payment of rent, you can cure the non-payment and prevent the eviction by paying your landlord all. At any stage of the eviction process, a tenant can attempt to stop eviction. Other than mentioned here, there really isn't a direct way to stop an eviction notice.
